Park Board-Gene Cleary- Bright Meadows walking path. Dearborn County Community
Foundation has pledged a \$50,000 grant and a private donation of \$50,000 has been received.
Only a \$96,000 remainder will be needed after this grant and donation, to complete this project.
Gene Cleary wanted to thank Tim Doll for all of his help in acquiring this money. Tim Doll
explained the project may receive Stellar Pathways money. Glenn Wright wants to know how the
Stellar Pathways will be used.

Dearborn County Regional Sewer District- Stewart Cline presented for the Dearborn County Regional Sewer District. Guilford includes 62 connections worth \$20,000 each. The residents do not take on that expense. Lake Dilldear is \$14,000 for each connection. Those residents will not be charged that particular charge for connection. They must hook on at the time of original installation, at the construction phase. They will be doing a rate study to determine those costs.

Guilford Sewer Treatment Facility- \$5,576,448.77

Lake Dilldear Sewer Lines- \$2,538,288.72

Motion to approve \$8,114,737.49 for Sewer Projects out of ARPA Funds by Kevin Turner, seconded by Glenn Wright, motion passed unanimously.

PUBLIC COMMENT- Chris Mueller asks for the numbers for the sewer projects. The Auditor will provide them.


